Eurofinanziaria S.p.a. and Paoletta Garden S.r.l. sets out to manage the data supplied in the full respect of current laws on the protection of personal data. To this regard it aims in this page to supply all its users with information on the manner and purposes of personal data processing in accordance with the provisions of art. 13 of the Legislative Decree no. 196 dated 30.06.2003. The personal data supplied by users will be processed electronically and/or manually by Eurofinanziaria and Paoletta Garden, Milan, the data controller, for all the purposes inherent to provision of the service. The provision of the data to be inserted in the spaces marked is obligatory for use of the service; consequently failure to insert obligatory data will prevent access to the service.

Art. 7 Legislative Decree dated 30.06.2003:

1. The data subject has the right to obtain confirmation as to whether or not personal data concerning him/her exists, regardless of its being already recorded, and to the communication of such data in an intelligible form.
2. The data subject has the right to be informed a) of the source of the personal data; b) of the purposes and methods of the processing; c) of the logic applied to the processing, if the latter is carried out with the help of electronic means; d) of the identification data concerning the data controller, data processors and the representative designated as per Article 5 sub-paragraph 2; e) of the entities or categories of entity to whom or which the personal data may be communicated and who or which may get to know the said data in their capacity as designated representatives in the territory of the state, as data processor(s) or as person(s) in charge of the processing.
3. A data subject shall have the right to obtain a) updating, rectification or, where interested therein, integration of the data; b) erasure, rendering in anonymous form or blocking of data that has been processed unlawfully, including data the retention of which is unnecessary for the purposes for which they have been collected or subsequently processed; c) certification to the effect that the operations as per letters a) and b) have been notified, as also related to their contents, to the entities to whom or which the data was communicated or disseminated, unless this requirement proves impossible or involves a manifestly disproportionate effort compared with the right that is to be protected.
4. The data subject has the right to object, in whole or in part, a) on legitimate grounds, to the processing of personal data concerning him/her, even if relevant to the purpose of the collection; b) to the processing of personal data concerning him/her, where it is carried out for the purpose of sending advertising material or direct selling or else for the performance of market or commercial communication surveys.

The user may exercise the rights as in art. 7 of the Legislative Decree 196/2003, (updating, correction, integration, cancellation, transformation into an anonymous form or blocking of the data processed unlawfully, objecting, requesting information as in the 1st paragraph and as in letters a), b), c), d), e) 2nd paragraph), by contacting info@adihotels.com.

The identification data of the company was taken from public lists and registers or in any case from documents accessible to anyone so as to perform our marketing activities in the future. It will be processed by the company on paper and /or in computerised or telematic form and will be used exclusively by our company in relation to our needs, including future needs, to acquire new clients

The company guarantees the maximum confidentiality when processing the data and the option to request, free of charge, the cancellation (or correction) of your data contained in our archive. The company is entitled to exercise all the rights as per Article 7 of the Legislative Decree no.196/2003 and specifically to object to all or a part of such being processed.
